**Announcement of GRESB in 2024 Assessment Results**

Diamond Realty Management Inc. ("DREAM") announces that our Private REIT; DREAM Private REIT Inc. ("DPR"), which has commissioned DREAM to manage its assets, is designated by the GRESB Real Estate Assessment in 2024, as the highest "5 Stars" rating for the third consecutive year, and "Green Star" for seventh consecutive year, achieving high performance within the participants.

**1. Assessment Results**

DPR received a "5 Stars" in GRESB Rating for the third consecutive year, which is based on GRESB Overall Score and its quintile position relative to global participants, which shows within the top 20%. DPR also won a "Green Star" designation for the seventh consecutive year by achieving high performance both in "Management Component" that evaluates policies and organizational structure for ESG promotion, and "Performance Component" that assesses environmental performance and tenant engagement of properties owned.

GRESB is an annual benchmarking assessment to measure ESG (Environmental, Social and Governance) integration of real estate companies and funds, as well as the name of organization which runs the assessment. It was founded in 2009 by a group of major European pension funds who played leading roles in launching Principles for Responsible Investment (PRI).
